**PRETRIAL ORDER NO. 63
(Amending Schedule Through Trial)**

1. AND NOW, this 9th day of June 2014, upon consideration of the Joint Motion to Amend/Correct Pretrial Order Nos. 39, 44, 51, and 56 [MDL Doc. No. 946], after a status conference held this date, and in recognition that discovery and trial issues are most efficiently handled by the entry of Pretrial Orders, and upon consideration of the scope of these proceedings, the amount of discovery that will be required to prepare cases for trial, the time necessary to complete pre-trial preparations, and the Joint Proposal of Plaintiffs' and Defendants' Counsel, pursuant to Pretrial Order No. 57, it is **ORDERED** that the Motion is **GRANTED**. The Court hereby enters this Pretrial Order amending Pretrial Orders Nos. 39, 44, 51 and 56 to govern the schedule for discovery, trial pool selection, other pretrial proceedings, and trial, subject to entry of subsequent Pretrial Orders modifying or supplementing this Pretrial Order.
